5:35 PM - Discussion and review of the Interlocal Agreement between Treasure County and the Town of Hysham


- The agreement typically runs in five-year increments.
- Discussion of being double charged for town residents.
- Discussion regarding the rates increase in reference to the canister site, solid waste and water rate.
- Discussion of the Capital Project fund that Sheriff Seastrom wanted to initiate for law enforcement services.
- Discussion of creating a county capital project fund for the Hysham Pool
  - Water pump costs continue to increase. This fiscal year alone \$8,300.00 has been spent on the pumps.
  - Discussion of the town and county placing back a set amount of funds per year to build an expense budget in the event a pump has to be replaced.
  - Rates discussed
    - Town \$250 - \$500
    - County \$500 - \$ 750
    - The consensus between both Council and Commissioners was that it is a start and no matter what the rate it is better than 0.
- Discussion of Fire Equipment and Department Services
- County/Town Attorney Schantz will update the Interlocal Agreement pursuant to the discussion at the meeting and circulate it to the Town of Hysham County and Treasure County Board of Commissioners for approval at future meetings.
