 - Commissioner Mochr requested that the completion of the cattleguard placement should be by July 1*.
 - Discussion of weed spraying at the Cemetery and school football field. It was suggested

2:00 PM - Montana Association of Counties - Property & Casualty Trust

- Hope Barker was present to go over the Property & Casualty Trust numbers this year, along with Joel Larson the County Insurance Agent.
- The insurance premium went down 8.74% with approximately \$10,000.00 of savings for the County.
- O Workman's Compensation, however, increased from approximately \$11,000 to \$17,000 due to a claim that occurred in 2023. Mr. Larson said that it takes approximately 4 years for a claim to "fall off" therefore to expect rates to stay a little bit higher than normal.

2:30 PM - Firehall Water with Town representatives, Mayor Kenny Rolandson and Town Council Member, Wesley Duncan

- o Present were guests Tommy and Karen Van Haele and County Attorney Hanna Schantz
- Water on the Main Street firehall project.
- o There are issues regarding where to connect the main firehall water in regards to curb stops. There are multiple curb stops close. One issue is that the county does not want to go through private property to connect to a curb stop. One curb stop was/is decommissioned. There were various suggestions and recommendations given by town representatives and the commission. Commissioner Moehr actually went and looked at the site with Kenny and Wes. Ultimately this discussion was tabled.

 - The town would like to place four new meters to show the water used. The town offered to cover half of the cost of the four new meters if the county would cover the other half. It was questioned that the town should cover the whole cost of the meters.
