 - Influenza vaccine, Deb is hoping to utilize the PHARM406 as a source of the vaccine so the health department doesn't have to have as much vaccine dosage on hand. She is thinking to acquire 50 doses and review once the PHARM406 has had their vaccination clinic.
 - Deb does plan to host a drive through clinic, which there was little participation last year.
 - The health department will also have a school-based clinic to ensure the children receive the vaccinations that are needed.

- o Rate Update for January 1, 2026 through December 31*, 2026
 - Discussion regarding a change in legislature regarding the Pharmacy's allowed dispense Fee. This will not begin in 2026 but could occur in 2027. Typical process fees for rural pharmacy's is 10-15.00. This law kicks in on October 1*, 2025.
 - There was a 4.7% increase in the Dental plan from \$41 to \$43 dollars
 - This comes with a \$400. Benefit coverage
 - There was a 9.8% increase from the Medical Rates.
 - The county cap amount for calendar year 2025 is currently \$1,192.00 per employee.
 - The rate increases will up the county cap amount for 2026 at \$1,305.00 per employee.
 - Vision and Life rates stayed the same.
 - Discussion of Permissive Medical Levy Fund
 - Discussion of working hours to be offered insurance is currently at 87 hours.
 - Discussion regarding Workman's Comp, with sick and vacation time and also FMLA Leave.
